DISCUSS TRAFFIC CONCERNS

Mr. Tallant noticed the traffic lines on Main Street between 4th and 5th street need to be painted. The lines are hard to see at night and are curved.

Mr. Gonzales noticed a missing street sign at Holly and Kingston. Mr. Lee added that there is a new legal size for street signs. The first letter of street name should be uppercase and all other letters should be lowercase. {If speed limit is more than 25mph the sign should be a 9" blade with 6" letters.}

Mr. Albrecht mentioned that the signal light at Ranchwood and Main Street needs to be adjusted and angle away from morning sunlight. Captain Merry will check the street light at this location. Mr. Lee mentioned that the light could also just be dimmed.

Captain Merry mentioned his traffic concerns for the new highschool next year and the railroad crossing at Ranchwood Blvd.

Captain Merry will bring information for the new traffic laws to next meeting.

Mr. Shivers announced that the next road project for the City of Yukon will start soon. The location will be Highway 4 north from Highway 66 to Wilshire Blvd.
