## Minutes of October 6, 1959

The City Council of the City of Yukon, Canadian County, State of Oklahoma, met in regular session in the office of the City Clerk at the City Hall in said City, on the 6th day of October, 1959, at 8:00 A.M.

PRESENT: Councilmen Frank, Greene, Seikel, Turner and Mayor Belisle, Iva Nelson, City Clerk.

ABSENT: None.

There upon Councilman Belisle introduced a resolution which was read in full by the City Clerk, and upon a motion made by Councilman Seikel, seconded by Councilman Greene was adopted by the following vote:

AYES: Councilmen Frank, Greene, Seikel, Turner and Mayor Belisle.

NAYES: None.

Said Resolution was thereupon signed by the Mayor, attested by the City Clerk, sealed with the seal of said City, numbered, and is as follows:

RESOLUTION NO. 4-59

A RESOLUTION VALIDATING AND APPROVING ACTIONS OF THE GOVERNING BODY OF YUKON BETWEEN AUGUST 31, 1959, AND SEPTEMBER 28, 1959.

WHEREAS, the City of Yukon Charter which made the Town of Yukon a City of the first class on September 28, 1959, was approved by the Governor on August 31, 1959; and

WHEREAS, it became the policy of the officials of Yukon to treat themselves as a City insofar as the governing body was concerned after August 31, 1959; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE 'CITY OF YUKON, OF THE STATE OF OKLAHOMA:

Section 1. That all actions of the governing body of Yukon wherein the same was called City Council prior to September 28, 1959, including the use of the term Mayor, City Clerk and Councilmen in lieu of President, Board of Trustees, Town Clerk and Trustees are hereby validated, confirmed and approved.
