

OWNER'S CERTIFICATE AND DEDICATIONS

KNOW ALL MEN BY THESE PRESENTS that the undersigned, RETAIL BUILDINGS, INC., an Oklahoma Corporation, hereby certifies that it is the owner of the legal title and the only person, firm or corporation having any legal right, title or interest in and to the land shown on the annexed map or plat of BRAUM'S ADDITION, an addition to the City of Yukon, being a part of the NE 1/4, Sec. 30, T 12 N, R 5 W, Canadian County, Oklahoma, and do further certify:

THAT as the owner of the title to said land which is shown and described on the annexed plat of BRAUM'S ADDITION, does hereby dedicate the streets and avenues shown on said map or plat for the uses of the public, for their successors and assigns, and guarantee a clear title to said land and have caused the same to be released of all encumbrances so that the title is clear, except as shown in the Bonded Abstractor's Certificate hereon.

THAT the areas indicated on said plat as drainage or utility easements are hereby reserved of the purposes of locating, constructing, erecting, maintaining, conducting and performing any public or quasi-public utility function or service above or beneath the surface of the ground with rights of ingress and egress at any time for the purpose of installation, repair maintenance, operation and removal of any such public or quasi-public utility.

SAID property covered by this plat and this dedication are subject to certain restrictions, reservations and covenants contained in a separate instrument which may be filed subsequent to the filing of the plat.

A Tract or parcel of land lying in the Northeast Quarter (NE 1/4) of section 30, Township 12 North, Range 5 West of the Indian Meridian, Canadian County, Oklahoma, more particularly described as follows:

Commencing at the Northeast corner of said NE 1/4;
Thence S. 00° 15' 13" E. and along the East line of said NE 1/4 for a SURVEYOR'S NOTARY distance of 1512.93 feet;
Thence S. 89° 44' 47" W. for a distance of 125.00 feet for a Point of Beginning, said point being the Southeast corner of Lot 1, Hilltop View Addition to the City of Yukon, Oklahoma, and also being on the West right-of-way line of S.H. 92;
Thence S. 00° 15' 13" E. and along said West right-of-way for a distance of 220.60 feet to the North right-of-way of Interstate Highway No. 40;
